

Terms of NAVY & GREEN LOYALTY CARD

The following terms regulate the operation of the NAVY & GREEN LOYALTY CARD. The NAVY & GREEN LOYALTY CARD is a program through which members provide rewarding shopping, special offers, privileged information on new products, participation in contests and sweepstakes -and other privileges as specified below. The signature and submission (in physical / electronic form) of the membership application in NAVY & GREEN LOYALTY CARD means that the applicant is aware of the following terms and accept that they only regulate the rights and obligations of any member of this program.

MEMBERSHIP: Any natural person over 16 years of age or legal person is entitled to complete the relevant application for membership either in physical form, which will procure and present exclusively in any physical store network of NAVY & GREEN shops within of Greek territory, or electronically through www.navygreen.gr website. The membership card is activated in one of the branches of the network of NAVY & GREEN stores and can be used immediately if it is sufficiently completed, signed application and delivered to the store. The online application will be completed through www.navygreen.gr Once considered the application data is correct for example the email of the client has @, will be sent an email to the member in order to be informed about the activation of the card, the card code and the security code. The security code concerning transactions carried out by the www.navygreen.gr online store.

The applicant becomes a member and entitled to the following privileges when he takes the card enabled with the elements of a new member of any branch of the branch network of ADAMAKOS BROS SA either via an e-mail from the NAVY & GREEN LOYALTY CARD , if the application is done online.

1. Returns of Products: Items purchased from the members, will not be returned and if the product is not the same and it is required to be accompanied by the document of purchase of the existing transaction.

2. Membership Cancellation: The member will make a written announcement, that wants to be deleted from the NAVY & GREEN LOYALTY card, and will have the possibility for one (1) month from the date of notification of the cancellation.

3. Membership and any vested benefits can not be transferred and may not be assigned for any reason and in any manner.

4. The Members should notify for any change of their data, which have provided in their initial application via e-mail at the email address: card@navygreen.gr, otherwise ADAMAKOS BROS SA will not be responsible for any loss or interruption of mail communication.

5. In case of loss or destruction of the card the cardholder must declare ADAMAKOS Bros. SA in order to avoid fraudulent use of this and will be able to replace it.

6. ADAMAKOS BROS SA preserves the right to cancel the membership NAVY & GREEN LOYALTY CARD and delete or cancel any privileges, if the member does not respect the terms of use of the card or makes wrong use of the card.

7. ADAMAKOS BROS SA preserves the right at any time to dissolve NAVY & GREEN LOYALTY CARD on condition that will notify the members two (2) months

before through the site www.navygreen.gr in the section NAVY & GREEN LOYALTY CARD News (unless if the dilution is forced by majeure or by judicial or administrative decision or actions) and taking into account the vested privileges of members from their participation in the NAVY & GREEN LOYALTY CARD.
